A regular meeting of the Board of Education of the San Diego Unified School District, County of San Diego, California, was held in the Auditorium of the Eugene Brucker Education Center 4100 Normal Street, San Diego, California on January 23, 2007.

Call to President Acle called the meeting to order at 12:00 p.m. in Room 2249.

Having completed the Closed Session, President Acle reconvened the meeting in Open Call to

Report of President Acle stated that the Governing Board had been meeting in Closed Session regarding matters listed on today's Closed Session agenda and wished to announce that Closed

Adoption of a Memorandum of Understanding between the San Diego Unified School and the San Diego

Education Association, as the exclusive representative of the Certificated

John Muir School bargaining unit regarding the teacher moves at John Muir School during June of 2005, in accordance with Section 3547.5 of the California Government Code and Section 1031 of the Bylaws of the Board of Education. (Attachment 7.a.3.)

It was moved by Member de Beck, seconded by Member Lee that the Memorandum of Understanding be approved. The motion carried, with all voting yes.

Contract Waiver Request

Adoption of a Contract Waiver Request by the San Diego Unified School District to Article 25 – Education Reform and Shared Decisionmaking, Section 25.5.2., requesting an extension to the deadline of February 1 for sites to complete the decisionmaking process for the elimination of existing bargaining unit positions, in accordance with Section 3547.5 of the California Government Code and Section 1031 of the Bylaws of the Board of Education. It was moved by Member de Beck, seconded by Member Lee to approve the contract waiver request. The motion carried, with all voting yes.

MOU Adoption of a Memorandum of Understanding between the San Diego Unified School District SDEA and the San Diego Education Association, as the exclusive representative of the Certificated

Lincoln High School bargaining unit regarding Lincoln High School being considered as a Section 12.1.11 – Academic Performance Index 1-3 School, in accordance with Section 3547.5 of the California

Government Code and Section 1031 of the Bylaws of the Board of Education.

It was moved by Member Jackson, seconded by Member Lee to approve the Memorandum of Understanding. The motion carried, with all voting yes.

HPSGP

Approval of the High Priority Schools Grant Program (HPSGP) Implementation applications for 12 district schools. The selected schools are all Decile 1 or 2 schools that have not previously received funding from the Immediate Intervention/Underperforming Schools Program, the High Priority Schools Grant Program, or the Comprehensive School Reform Program. (Attachment 7.b.1.)

It was moved by Member de Beck, seconded by Member Lee to approve the applications. The motion carried, with all voting yes.

Title I

2007-08 Plan for Title I Eligibility Ranking and Participation. (Attachment 7.b.2.)

David Page addressed the Board in Public Testimony prior to the vote on the above item.

It was moved by Member de Beck, seconded by Member Nakamura to approve the Title I Eligibility Ranking plan. The motion carried, with all voting yes.

9th Grade Intervention Program Educational Interventions to Promote Academic Success: Establishment of a Transitional 9th Grade Intervention Program. Students who have two or more "F's" in core academic classes at the end of 8th grade will be assigned to a transitional 9th grade program to be designed by, and operated at, the individual high schools. (Attachment 7.b.3.)

The following individuals provided public testimony to the Board regarding item 7.b.3., educational intervention to promote academic success: Jeff Olivero, Eric Kangas, Nancy Regas, Kristi Dean, Dr. Dorothy Smith, Tom Guerin, Robert Grano, and Zoneice Jones,

Motion made by member de Beck, seconded by member Lee stating, the San Diego Board of Education believes that student achievement is sequential and that success in school requires meeting standards in elementary, middle and high school. Therefore, it shall be the policy of the District that any student at any grade that is far below basic on both the mathematics and language portions of the State Standards test shall be recommended for retention. When retention is recommended by the school, parents may require promotion, but will agree to place their children in mandatory summer and extended day programs available to assist their

children in meeting minimum standards. No child shall be retained more than once in elementary school and once in middle school. This policy shall take effect for the 2006-07 school year. Implementation of this policy shall be the responsibility of the superintendent and staff. The motion failed with members de Beck and Lee voting yes and members Acle, Jackson, and Nakamura voting no.

Motion made by member Jackson, seconded by member Nakamura supporting the Superintendent's recommendation that the Superintendent be authorized to take the actions which he deems necessary and appropriate to implement the Transitional 9th Grade Intervention Program. This program will begin with the 8th grade class of 2006-07 students with two or more grades of "F" in core academic classes (English, Math, History, Science) at the end of their 8th grade year will be assigned to a 9th grade transitional intervention program at their high school site. Because each high school will create its own plan for this 9th grade intervention, site requests for any additional funding will be considered on a per pupil basis and subject to the approval of the Assistant Superintendent and Executive Director who supervise the high schools. The Superintendent shall return to the Board in February with a policy for other grade levels. The motion failed with member Jackson voting yes and members Acle, de Beck, Lee, and Nakamura voting no.

Prior to the vote on the above motion, the following proposed amendments to the motion were discussed.

Board member de Beck proposed an amendment to the above motion stating that 8th grade students with two or more "F" grades in English or Math courses will be retained and students with two or more "D" grades will be assigned to a 9th grade transitional intervention program. The proposed amendment died for lack of a second.

Member Nakamura proposed an amendment to the above motion stating that 8th grade students with two more "F" grades in core academic subjects be retained. The motion died for lack of a second.

Motion made by member Nakamura, seconded by member de Beck stating that 8th grade students with 2 or more "F" grades, beginning in the 2006-07 school year, in core subjects (English, Math, History, Science) shall be retained. Parents will have the right to decline having their student retained in the 8th grade but the student will be assigned to the 9th grade transitional intervention program at the high school. The motion passed with members Acle, de Beck, Lee, and Nakamura voting yes and member Jackson voting no.
