On ballots 1 through 23, no candidate received the vote of a majority of the Board. Members Acle and Jackson voted for member Jackson, members Lee and de Beck voted for member de Beck, and member Nakamura voted for member Nakamura.

At approximately 6:25 p.m., members Lee and de Beck left the meeting room. On ballot 24, for the Office of Vice President member Acle voted for member Lee and members Jackson and Nakamura voted for member Jackson.

On ballot 25, member Shelia Jackson received the votes of members Acle, Jackson and Nakamura. Board Action Officer Cheryl Ward declared that member Shelia Jackson had been elected Vice President of the Board of Education to serve the period December 13, 2006 through December 11, 2007.
