 Approval of Energy Services Agreement(s) for Specified Sites commencing on the Commencement Date and terminating 20 years thereafter between the San Diego Unified School District and Solar Power & Electric I, LLC, and SCR Group, Inc. (C-7361).

On November 9, 2004, the Board authorized District staff to enter into an agreement with Solar Power & Electric I, LLC, and SCR Group, Inc. that provides below market, predictable-rate electricity to the District via a photovoltaic roof-mounted system. This agreement revised a previous agreement, approved by the Board on December 9, 2003 that was concluded in response to a district Request for Proposal soliciting on-site, below market and predictable electricity generation. We entered into the agreement with Solar Power and Electric Lessee One LLC, after a proper review and rating of their proposal by district staff. A significant "bonus" to the agreement is that under its terms designated district roofs were replaced with photovoltaic membranes at no cost to the district. To date fourteen photovoltaic roof systems have been completed. Since the December report, the district has received approval of a renewable energy rebate for Challenger Middle School, and we were able to place more photovoltaic panels than anticipated at the Wilson and Hale sites.

This report will authorize Energy Services Agreements for the previously approved sites, as well as authorize additional energy services agreements at the sites of Lindbergh, Green, and Dailard Elementary Schools, and Bell Junior High School, respectively (see attached exhibit).

Approval of Future Thurgood Marshall Middle School Change Order No. 00040C to Contract C-7175 – Future Thurgood Marshall Middle School New School Project: This change order submitted by SOLPAC, INC. dba Soltek Pacific for the Future Thurgood Marshall Middle School provides for long-term storage, protection, and double handling costs of structural steel due to the delayed project start.

This change order totals \$187,415 and represents 0.36% of the contract value. The total of approved change orders to date is (\$1,736,324) which is (3.36%) of the contract value.
