### 1. PROPOSED RESTRUCTURING PLANS FOR DESIGNATED DISTRICT SCHOOLS IN TITLE I PROGRAM IMPROVEMENT YEAR 4

Approval of restructuring plans (with specified modifications) for Baker Elementary, Bell Junior High, and Farb, Kroc, Roosevelt, and Taft middle schools for implementation in the 2006-07 school year; services to the above-mentioned schools in the amount of \$3,515,418 (Title I funding); and recommendation that any additional modifications/adjustments to the restructuring plans for the above-mentioned schools in 2007-08 be reviewed with the Board of Education prior to the 2007-08 school year. Under The No Child Left Behind Act of 2001, all Title I schools that do not make Adequate Yearly Progress (AYP) for two consecutive years are identified as Program Improvement (PI). There are required services and/or interventions that schools must implement during each year they are in PI status. A requirement for schools in PI Year 4 is to prepare a restructuring plan including alternative governance at the school to be implemented in Year 5. District schools in PI Year 4 have been meeting on a regular basis with their School Work Groups to examine their school data, determine school needs, and develop a restructuring proposal. The Board of Education reviewed the proposed plans as a first reading at their meeting on February 28, 2006. District departments have reviewed the restructuring proposals and have provided feedback to principals and work groups. The Superintendent and staff recommend that the restructuring plans (with specified modifications) for Baker Elementary; Bell Junior High; and Farb, Kroc, Roosevelt, and Taft middle schools be approved for implementation in the 2006-07 school year, and that any additional modifications/adjustments to the plans for 2007-08 be reviewed with the Board of Education prior to the 2007-08 school year. To remedy this situation, CELDT SEARCH was developed as a service of the San Diego County Office of Education (SDCOE) to collect and share CELDT results in a timely and accurate manner. SDCOE will coordinate the process of collecting CELDT results from participating districts, develop and maintain a searchable database, ensure the confidentiality of records and their consistency with FERPA (Family Education Rights and Privacy Act, 20 U.S.C. 1232g), provide technical assistance to participating districts, and monitor the frequency of the use of the service. Cost for participation in CELDT SEARCH is \$0.17 per assessed student (an estimated \$5,000-7,000 per year for the district), and will be supported by EIA-LEP funds.  Assignment of Agreement of Purchase and Sale dated October 27, 2004, amended March 10, 2005, May 24, 2005, October 6, 2005 and December 16, 2005, of the property located at 5897 Copley Drive, San Diego, California, APN 356-400-34 to Sudberry Development, Inc., from Home Depot U.S.A., Inc.

Home Depot U.S.A., Inc. (Home Depot) entered into an agreement to purchase the district's property at 5897 Copley Drive, San Diego, and escrow has been opened. Home Depot has requested the district's approval to assign Home Depot's interest in the property to Sudberry Development, Inc. Sudberry intends to construct office buildings on the property; this plan is consistent with the existing development entitlements and would not require further discretionary review by the City of San Diego. In accordance with the terms of the agreement, any assignment of the agreement requires prior written consent by the district, which consent may be withheld at the district's sole discretion. Approval of this agenda item will authorize the assignment of the Agreement of Purchase and Sale for the Copley Drive property from Home Depot, U.S.A., Inc. to Sudberry Development, Inc. All other terms and conditions of the Agreement of Purchase and Sale as amended will remain the same. [Originator-Chief Facilities Officer]

2. Categorical Exemption for demolition and reconstruction of public school facilities at Sherman Elementary School as set forth under Proposition MM in compliance with Section 15302 of the California Environmental Quality Act of 1970 and authorization to file the Notice of Exemption with County Clerk of San Diego, California.

Section 15302 of the California Environmental Quality Act of 1970 provides a categorical exemption for the replacement or reconstruction of existing structures or facilities where the new structure will be located on the same site as the structure replaced and will have substantially the same purpose and capacity as the structure replaced. The San Diego Unified School District plans to remove all existing structures on the existing Sherman Elementary School site and construct a new Sherman Elementary School on the site. All construction will take place on existing, District-owned school property. The school will not be expanded beyond its present capacity. Copies of the Notice of Exemption are available for review at the District's Maintenance & Operations Department, Architectural Program office.

It is recommended that the Board of Education:

a. Certify it has considered the proposed Notice of Exemption for the Sherman Elementary School reconstruction.

- b. Certify that the school reconstruction and operation will be consistent with present use of the site and will not involve expansion of use beyond that which presently exists.

- e. Find, based on the Notice of Exemption, that there is no substantial evidence that the project will have a significant effect on the environment.

# **Construction Change Orders**

3. Approval of Language Academy Elementary School Change Order Nos. C042, C071, C078, C079, C085, and C092 to Contract C-7076 with Erickson-Hall Construction Co. for removal of expansive soils; installation of handrails, variable-air-volume valves, and ADA ramps; an electrical water heater; water meter installation delays; and extended overhead. These change orders extend the contract by 18 days and increase the contract value in the amount of \$87,711 for a cumulative contract rate of 11.67%.

Language Academy Elementary School and Montezuma Child Development Center Modernization Project: These change orders for the Language Academy submitted by Erickson-Hall Construction Co. provide for removal of expansive soil beneath the new library building, installation of 135 feet of galvanized hand railing for the 400 and 700 buildings, extended overhead for 18 days due to water meter installation delays, installation of three variable-airvolume valves on the new HVAC system, installation of an electric water heater in lieu of the gas one included in the contract, and installation of three access ramps at three doorways.

These change orders extend the contract by 18 days and total \$87,711, representing 1.69% of the contract value. The total of approved change orders to date is \$517,752 which is 9.98% of the contract value. Board of Education approval is required for changes above \$100,000 or cumulatively over 10% of the contract value. Contract C-7076 for the Language Academy Elementary School and Montezuma CDC Modernization Project was board approved on April 9, 2004, at an original contract value of \$5,188,000. 4. Approval of Golden Hill Elementary School, Increment 2, Change Order Nos. 35.1, 64, 135, 186, 237, 251, 285, 294, 297, and 306 to Contract C-7082 with SOLPAC, INC. dba Soltek Pacific These change orders increase the contract value in the amount of \$104,674 for a cumulative contract rate of 10.48%.

Golden Hill Elementary School, Increment 2 Project: These change orders submitted by SOLPAC, INC. dba Soltek Pacific for Golden Hill Elementary School provide for window revisions to meet the required fire ratings, relocation of can wash and mop sink utilities to the

outside of the building, addition of cleanouts at rainwater leaders to allow for future maintenance, curb and gutter revisions at C Street and 33<sup>rd</sup> Street to correct design elevations, application of grout and face shells to concrete masonry units to eliminate potential water intrusion, relocation of passenger drop-off zone to eliminate mid-street crossing and a ramp addition from Building D to A Street, addition of safety fencing and railing in various locations to eliminate fall hazards, addition of retaining wall to resolve grading issues around fire post indicator valves, and payment of SDGE utility services during transition from Partial Occupancy to Substantial Completion of the project.

These change orders total \$104,674 and represent 0.57% of the contract value. The total of approved change orders to date is \$1,812,819 which is 9.91% of the contract value. Board of Education approval is required for changes above \$100,000 or cumulatively over 10% of the contract value. Contract C-7082 for the Golden Hill Elementary School, Increment 2 Project was board approved on June 30, 2004, at an original contract value of \$18,300,000. ### Joint Use Agreements

5. Renewal of Joint Use Agreement Between the San Diego Unified School District and the City of San Diego for Turfed Fields and Recreational Facilities at Valencia Park Elementary School for a 25-year period.

On October 10, 1979, the District entered into a 25-year joint use agreement with the City of San Diego for a turfed field and recreational facilities at Valencia Park Elementary School. On July 14, 2003, the Board of Education approved an "Amendment for the Extension of Certain Joint Use Agreements Between the City of San Diego and the San Diego Unified School District" to allow the City and District time to negotiate and enter into replacement joint use agreements. The City and District are desirous of renewing the joint use agreement for another 25-year period. The joint use facilities consist of 6.78 acres of district-owned property. The field and facilities within the joint use area are available for exclusive district use during normal school hours and for general community use at all other times. The City and District anticipate parity will be achieved in the year 2015. The District will be required to fund fifty percent (50%) of the maintenance costs. The current annual maintenance costs for this site is \$50,820. The District is seeking agreement with the City to consolidate all of the agreements for purposes of determining "total parity" at which time the District would begin making payments to the City. Once payments become due, the District will access property management funds as the funding source. This joint use agreement is consistent with the City/District Recreation Agreement of 1948 and the "Memorandum of Understanding Between the City of San Diego and San Diego Unified School District for Development and Maintenance of Joint Use Facilities" which was approved by the City Council on October 7, 2002, and by the Board of Education on October 8, 2002. The San Diego City Council approved this joint use agreement on October 24, 2005. Approval of this agenda item will authorize the Chief Facilities Officer, Facilities Management, or his designee, to execute the joint use agreement. [Originator-Chief Facilities Officer]

6. Renewal of Joint Use Agreement Between the San Diego Unified School District and the City of San Diego for Turfed Fields and Recreational Facilities at Penn Elementary School for a 25-year period.

On October 17, 1979, the District entered into a 25-year joint use agreement with the City of San Diego for a turfed field and recreational facilities at Penn Elementary School. On July 14, 2003, the Board of Education approved an "Amendment for the Extension of Certain Joint Use Agreements Between the City of San Diego and the San Diego Unified School District" to allow the City and District time to negotiate and enter into replacement joint use agreements. The City and District are desirous of renewing the joint use agreement for another 25-year period. The joint use facilities consist of 2.38 acres of turfed field and .14 acres of parking lot all on district-owned property. The field and facilities within the joint use area are available for exclusive district use during normal school hours and for general community use at all other times. City shall be responsible for the maintenance and operation costs at City's sole cost and expense. This joint use agreement is consistent with the City/District Recreation Agreement of 1948 and the "Memorandum of Understanding Between the City of San Diego and San Diego Unified School District for Development and Maintenance of Joint Use Facilities" which was approved by the City Council on October 7, 2002, and by the Board of Education on October 8, 2002. The San Diego City Council approved this joint use agreement on October 24, 2005. Approval of this agenda item will authorize the Chief Facilities Officer, Facilities Management, or his designee, to execute the joint use agreement. [Originator-Chief Facilities Officer]

7. Renewal of Joint Use Agreement Between the San Diego Unified School District and the City of San Diego for Turfed Fields and Recreational Facilities at Serra High School for a 25-year period.

The City and District are desirous of renewing the joint use agreement for another 25-year period. The joint use facilities consist of 5.66 acres of district-owned property. The field and facilities within the joint use area are available for exclusive district use during normal school hours and for general community use at all other times. City shall be responsible for the maintenance and operation costs at City's sole cost and expense. This joint use agreement is consistent with the City/District Recreation Agreement of 1948 and the "Memorandum of Understanding Between the City of San Diego and San Diego Unified School District for Development and Maintenance of Joint Use Facilities" which was approved by the City Council on October 7, 2002, and by the Board of Education on October 8, 2002. The San Diego City Council approved this joint use agreement on October 24, 2005. 1. Actions to accept, budget, and spend income- No Agenda Items for March 28, 2006.

The Finance Report Section (8.d.) items consist of actions authorized under the California Constitution or legal statutes and are in accordance with administrative rules and regulations.

2. Transfer of appropriations. No Agenda Items For March 28, 2006.

The Finance Report Section (8.d.) items consist of actions authorized under the California Constitution or legal statutes and are in accordance with administrative rules and regulations.

#### Grant Applications/Awards

3. Project Aspire Grant (Counseling & Guidance Department)

The Project Aspire Grant for the Counseling & Guidance Department will focus on supporting the expansion of school-based counseling services to meet the growing academic, personal, social, and education needs of students. The goal of Project Aspire is to reduce the ratio of counselors to students that will better provide prevention and early intervention services to students. Counseling services contribute to the personal growth, educational development and emotional well being of students. Research has shown that high quality counseling services can improve students' academic achievement. Studies on the effect of school counseling have shown positive effects on students' grades, decrease in classroom disruptions, and positive effects on teachers' ability to manage classroom behavior effectively.

It is estimated that the cost of this project for FY 2006-2009 will be \$395,000 a year, for a three year period for a total of \$1,185,000. The funding for this project will be provided by the U. S. Department of Education, Elementary and Secondary Counseling Program. The direct cost of \$1,143,050 will be paid by the funding source. The indirect allowance (3.65%) for administrative costs of \$41,950 will be paid by the funding source. [Originator-Office of Resource Development/Counseling & Guidance Department]

4. Trace Self-Determined Employment (Special Education) The TRACE Self-Determined Employment program, funded by the State Council on Developmental Disabilities, will initiate and implement this program in collaboration with the Disabled Businesspersons Association. Mr. Miyares has been providing classroom instruction for individuals with disabilities for many years. During the first six months of the project, TRACE and Mr. Miyares will collaborate to develop a curriculum based on his existing model that will be tailored and adapted to the needs of students with developmental disabilities. A special parent component of the curriculum will also be developed. During the second semester, two groups of fifteen TRACE students will be provided a course of instruction in the adapted curriculum for 9 weeks, 3 hours a week. Components of the class will include the following: guest speakers with disabilities from the community who have successfully developed and managed their own businesses, information and instruction about the legal requirements of setting up businesses and obtaining financial support, budgeting and money management, obtaining support for business management, developing a business plan, teamwork and partnerships, inventions and unique products for marketing.

This project will improve student achievement because the students will benefit from knowledge delivered from the TRACE Self-Determined Employment Project curriculum. Students will develop project prototypes and inventions. Their project will be critiqued and evaluated for potential and feasibility to commercial markets. Students will also be supported to develop their own business plans for their final project.

It is estimated that the cost of this project for October 2006 – October 2007 will be \$150,000. The funding for this project will be provided by the State Council on Developmental Disabilities. The direct cost of \$144,690 will be paid by the funding source. The indirect allowance (3.65%) for administrative costs of \$5,310 will be paid by the funding source. [Originator-Office of Resource Development/TRACE Special Education]

#### 5. Trace Innovation For Transition (Special Education)

The TRACE Innovation for Transition, funded by the State Council on Developmental Disabilities, will focus on the students who fall into the category of medically fragile students. These students are significantly below average intellectual functioning existing concurrently with profound deficits in the area of adaptive behavior. The goal is to develop a collaborative program between SDCS and The ARC of San Diego demonstrating how even individuals with the most severe disabilities and medical conditions benefit from relationships with peers, community involvement and opportunities for active participation in their lives and the lives of others. The MOVE program provides teachers with a curriculum that infuses motor development with other functional skills. The TRACE Innovation for Transition will be trained in the MOVE curriculum. TRACE Innovation for Transition also will be working with local universities in providing interns to provide OT and PT services to the students. Technology purchased, using grant funds, will allow individuals opportunity to communicate choice, make decisions and engage with nondisabled peers.

This project will improve student achievement because the services and training that are key to the success of these individuals while in school programs are absent in the adult facilities. There are not individuals versed in assistive technology such as voice output devices that allow individuals opportunity to communicate choices, make decisions and engage in social interaction. There are no occupational or physical therapy services and a lack of staff training in these areas. With MOVE curriculum, persons considered medically fragile, for whom development of sitting and walking skills may note be attainable, have experienced improved health. Upright seating has

been found to "ease the coordination of breathing and swallowing when eating, and facilitate coughing, thus improving respiratory health." Recreational Therapist Programs and TRACE will jointly provide recreational opportunities in the community.

It is estimated that the cost of this project for October 2006 – October 2007 will be \$100,000. The funding for this project will be provided by the State Council on Developmental Disabilities. The direct cost of \$96,460 will be paid by the funding source. The indirect allowance (3.65%) for administrative costs of \$3,540 will be paid by the funding source. [Originator-Office of Resource Development/TRACE Special Education]

6. Trace Community Mapping (Special Education)

TRACE Community MAPPING, funded by the State Council on Developmental Disabilities, will initiate and implement project, TRACE Resources MAPPING, through which 60 students with developmental disabilities (mappers) and 20 college students (peer mentors) will engage in an intensive evaluation of the resources available in San Diego. Through this project, mappers and peer mentors will canvass their local community to discover what recreational, civic and employment opportunities exist. These activities will comprise a meaningful, paid work experience for the mappers and a stipend for the college peer mentors (SDSU Rehabilitation Students). Outcomes will include: Youth Mapping Website, workshops provided for community agencies, partners, parents, Student Manual, Parent Manual, Teacher Manual, Semi-annual Newsletter, proposed presentations at local and state conferences (SD People 1<sup>st</sup>, Imperial Valley People 1<sup>st</sup>, Supported Life, CAL-TASH).

The TRACE Resources Mapping Project will be a catalyst to motivate youth and adults to identify and expand on existing resources as well as to create new opportunities in our community. Meaningful participation by young people will involve planning, data collection and analysis and information dissemination. People will learn about their home neighborhood and opportunities that exist there. They will make connections with employers and other community leaders. Families will have increased awareness of how to access services and advocate for their family members with disabilities.

It is estimated that the cost of this project for October 2006 – October 2007 will be \$150,000. The funding for this project will be provided by the State Council on Developmental Disabilities. The direct cost of \$144,690 will be paid by the funding source. The indirect allowance (3.65%) for administrative costs of \$5,130 will be paid by the funding source. [Originator-Office of Resource Development/TRACE Special Education]

7. Starbucks Playground Improvement Grant (Angier Elementary School)

The artificial grass for Angier Elementary School will be funded by several sources. A request to the Chargers Champions grant has also been submitted for this purpose. The Playground Improvement program proposed to Starbucks Foundation will provide safe artificial grass area for physical education, ball wall, blacktop to improve playground, and portable sound system for uses outside at Angier Elementary School. The project will improve student achievement as physical fitness has been linked to gains in reading and math scores.

It is estimated that the cost of this project for the period June 1, 2006 – June 30, 2007 will be \$50,000. The funding for this project will be provided by the Starbucks Grant. The direct cost of \$48,230 will be paid by the funding source. The indirect allowance (3.67%) for administrative

costs of \$1,770 will be paid by the funding source. [Originator-Office of Resource Development/Angier Elementary School]

8. Capital Improvements – Classroom & Library Project Grant (Angier Elementary School) The Capital Improvements - Classroom & Library Project Grant (Angier Elementary School) from the Office of San Diego County Supervisor Ron Roberts will provide electronics used by teachers in the development of curriculum. Electronic tools will enhance teacher presentation in the classroom. The software/books for children to use in the library will improve student achievement by providing more choices for reading and learning in a positive environment for students.

It is estimated that the cost of this project for FY 2006-2007 will be \$20,000. The funding for this project will be provided by Supervisor Ron Roberts' Office Grant. The direct cost of \$19,292 will be paid by the funding source. The indirect allowance (3.67%) for administrative costs of \$708 will be paid by the funding source. [Originator-Office of Resource Development/Angier Elementary School]

9. Chargers Champions Standley Fitness Center Project Grant (Standley Middle School) The Standley Fitness Center Project proposed to the Chargers Champions grant program will fund the purchase of a locker bay to hold fitness machines already donated at Standley Middle School. In addition, older lockers will be removed, the area will be painted, and mat flooring and free weights will be purchased. The project will help to improve student achievement because as Fitnessgram scores improve, self-esteem and health are improved.

It is estimated that the cost of this project for the period May 1, 2006 – June 30, 2007 will be \$40,000. The funding for this project will be provided by the Chargers Champion Grant. The direct cost of \$38,584 will be paid by the funding source. The indirect allowance (3.67%) for administrative costs of \$1,416 will be paid by the funding source. [Originator-Office of Resource Development/Standley Middle School]

10. Charger Champions Synthetic Field Project Grant (Angier Elementary School) The Synthetic Field Project proposed to the Charger Champions grant program will provide a grass field to enhance an already thriving physical education program for the students at Angier Elementary. This new surface will enhance physical education by giving more options/resources for coaches and teachers to use in their teaching.

It is estimated that the cost of this project for FY 2006-2007 will be \$30,000. The funding for this project will be provided by the Chargers Champions Grant. The direct cost of \$28,938 will be paid by the funding source. The indirect allowance (3.67%) for administrative costs of \$1,062 will be paid by the funding source. [Originator-Office of Resource Development/Angier Elementary School]

11. "Universal Design For Learning" DTir Assigned Time Proposal – Differentiating Content, Product And Process Through Co-Teaching (Mann Middle Complex)
The "Universal Design for Learning" DTiR Assigned Time Proposal – Differentiating Content, Product and Process Through Co-Teaching through Cal State University San Marco (CSUSM)
will focus on creating a partnership between CSUSM and SDUSD to provide structures, support, and adult learning opportunities at the Mann Middle Complex to improve instructional practice in the area of co-teaching. This will be done by gaining an in-depth understanding of how to differentiate instruction by using Universal Design for Learning (UDL) principles. Dr. Jacqueline Thousand, Involved Faculty, CSUSM College of Education will be the principal investigator. The three schools at Mann Middle Complex will promote co-teaching and universal access to the curriculum throughout the district by becoming model demonstration light houses for other schools.

Improved student achievement will be attained by facilitating equitable access to the core curriculum for diverse learners and by improving the instructional practice of the teachers who will teach them.

This is a no cost grant for the period FY 2006 – 2007. The CSUSM faculty member will receive six assigned time units. There will be no indirect allowance for administrative costs. [Originator-Office of Resource Development/Mann Middle Complex]

12. Lowe's Landscape Beautification Project Grant (Angier Elementary School) The Landscape Beautification Project proposed to the Lowe's Home Improvement Center (#1013) will provide funding to beautify the learning environment on campus for all students at Angier

Elementary School. New plants and materials will be purchased. Partners include Lincoln Housing, Kiwanis, San Diego Master Gardeners, and USS Preble. Landscaping will be provided to improve the appearance of the school site.

It is estimated that the cost of this project for the period May 15, 2006 – May 15, 2007 will be \$5,000. The funding for this project will be provided by the Lowe's Home Improvement Center. The direct cost of \$4,823 will be paid by the funding source. The indirect allowance (3.67%) for administrative costs of \$177 will be paid by the funding source.
