### **Brief Explanation:**

As part of our Local Control Accountability Plan, our District is required to complete the California Healthy Kids Survey (CHKS), the California School Staff Survey (CSSS) and the California School Parent Survey (CSPS). The surveys are anonymous.

# California Healthy Kids Survey (CHKS)

The CHKS surveys students statewide and covers topics related to alcohol, tobacco, drugs, bullying, and other health issues such as school climate and student resiliency. Survey data will assist schools in: (1) preventing youth health-risk behaviors; (2) promoting positive youth development; and (3) fostering positive school climates. Each school site will receive, via email, its own unique URL link to an online survey that students will use to access the survey.

**Elementary Schools**: Active parent/guardian consent on behalf of each elementary fifth grade student is required to participate in the survey. Each school site sends home the "Consent for the California Healthy Kids Survey" to parents requesting permission for their students' participation. \*Note: In the Point Loma Cluster, fourth grade students will participate and require active parent consent.

**Secondary Schools**: At Grades 7, 9, and 11, students have passive parent consent to participate in the survey. Students' parents can select to opt-out on the 2019-2020 Student Enrollment Form by marking item number 28. The directions on how to print the PowerSchool "Opt Out" list will be provided to each testing coordinator in preparation for the CHKS administration.

# California School Staff Survey (CSSS)

Each school site will receive, via email, its own unique URL link to an online survey that each staff member assigned to the campus will use to access the survey. Every staff member, both certificated and classified, are encouraged to participate. The survey takes an average of 25 minutes to complete.

### California School Parent Survey (CSPS)

Each school site will receive a shipment, via distribution services, printed paper parent surveys for every student enrolled. Parents are asked to complete one parent survey per family per school. In addition to paper surveys, the parent survey will also be available online in English, Spanish and Chinese. Each school site will receive, via email, its own unique URL link for the CSPS. The Integrated Youth Services staff is available to assist your site with the distribution and collection of paper parent surveys.
